- 3/ Memberships are non-refundable and non-transferable.
- 4/ Applications for membership are approved or otherwise at the sole discretion of RVGC and membership does not commence until an application or renewal has been accepted by RVGC and the appropriate payment is received.
- 5/ Renewal subscription payments are due on the first day of the relevant subscription year. (1<sup>st</sup> May) If not paid in full on this date the membership is deemed to not be renewed and all membership rights will cease immediately until the renewal payment is made.
- 6/ Subscriptions are payable by cash, cheque or credit/debit cards.
- 7/ A monthly payment option is available at the discretion of RVGC.
